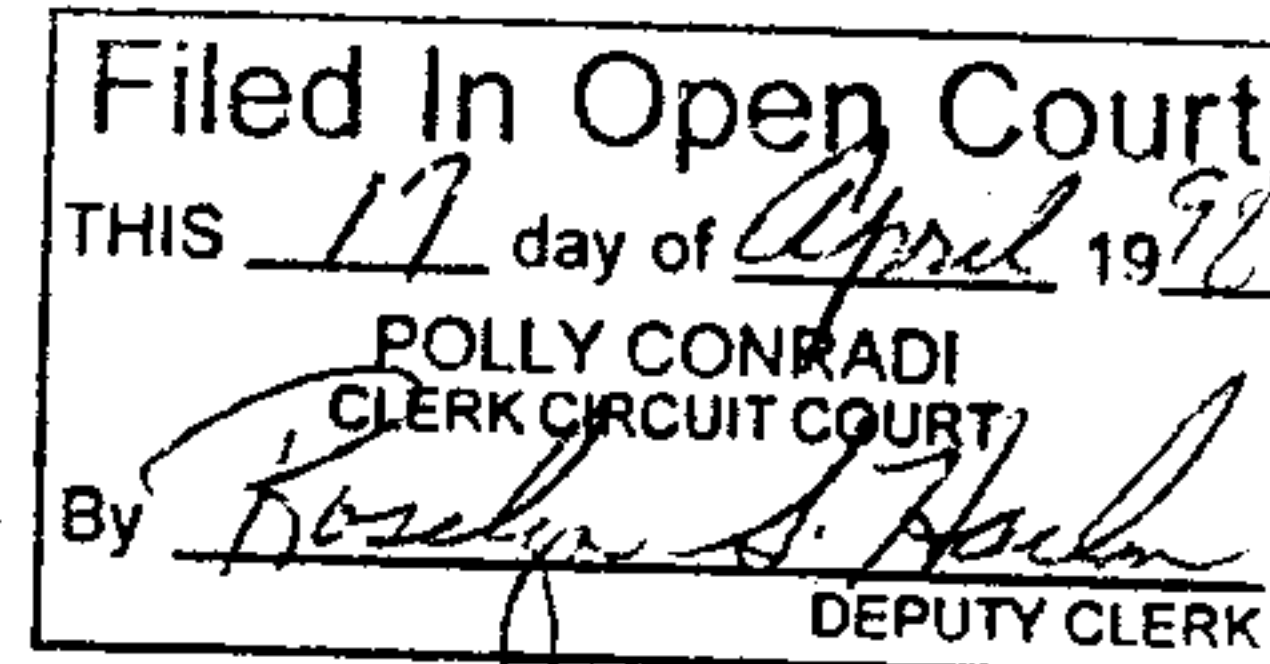

O R D E R

The Motion for Judgment by Default (as to defendant Michael W. McCowan), filed by the plaintiff in this case on April 3, 1998, came before the Court this date, there being no request for oral argument.

The defendant, MICHAEL W. McCOWAN, was served with the Summons & Complaint in this case on February 2, 1998; and said defendant has failed to file an answer or other affirmative pleading within the specified time period under the Birmingham Differential Case Management Plan.

After due consideration thereof, said Motion for Judgment by Default is GRANTED; and DEFAULT JUDGMENT is hereby entered in favor of the plaintiff and against the defendant, MICHAEL W. McCOWAN, for the sum of SIXTY-THREE THOUSAND SEVEN HUNDRED NINETY AND 56/100 (\$63,790.56) DOLLARS, which consists of the principal balance of \$54,599.61, interest in the amount of \$1,001.00, and a reasonable attorney's fee in the amount of \$8,189.95. Costs of court in connection therewith are taxed to the defendant, Michael W. McCowan.

This case remains pending on plaintiff's claim against the defendant, Sameta D. McCowan.
