ASSIGNMENT OF PROMISSORY NOTES

2. That certain Promissory Note dated April 6, 1988, and executed by Joseph A. LaRussa and wife, Sue J. LaRussa, payable to David Jones and wife, Mary Lou Jones, in the original principal sum of Seventy-five Thousand (\$75,000.00) Dollars, and the mortgage deed securing payment thereof recorded in Book 226, Page 707, of the Public Records of Shelby County, Alabama.
