**ARTICLES OF ORGANIZATION  
OF CHAROB, L.L.C.**

We, the undersigned, desiring to form a Limited Liability Company pursuant to the laws of the State of Alabama, certify as follows:

1. **Name.** The name of the Limited Liability Company is **ChaRob, L.L.C.**
2. **Duration.** The existence of the Limited Liability Company shall commence on the date of the filing of these Articles of Organization in the Office of the Judge of Probate of Shelby County, Alabama and shall be terminated December 31, 2055, provided, however, that the Limited Liability Company shall be dissolved prior to such date (a) upon the written consent of all of the members; or (b) as provided in the Operating Agreement; or (c) as may be required by the Alabama Limited Liability Company Act.
3. **Purpose.** The purpose for which this Limited Liability Company is organized is to engage in the buying, selling, developing and managing of real estate, and otherwise to engage in the transaction of any or all lawful businesses for which Limited Liability Companies may be organized under the laws of the State of Alabama.
4. **Initial Registered Office and Registered Agent.** The location and mailing address of the initial registered office shall be **800 Lewis Road, Chelsea, Alabama 35043** and the name of the initial registered agent at said address shall be **Charles F. Lewis, Jr.**
5. **Initial Members.** The names and mailing addresses of the initial members in the Limited Liability Company are as follows:

6. **Additional Members.** The members of the Limited Liability Company shall have the right to admit additional members to the Limited Liability Company upon the unanimous consent of all the members of the Limited Liability Company.





7. **Other Rights of Members.** The members of the Limited Liability Company shall have the right to continue the business of the Limited Liability Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member of the Limited Liability Company if (i) there are at least two remaining members or at least one remaining member and a new member is admitted; and (ii) the legal existence and business of the Limited Liability Company is continued by a written consent of all the remaining members within ninety (90) days after the occurrence of the event of dissociation.

8. **Management.** The Limited Liability Company shall be managed by the managers.
