WARRANTY DEED:

KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of Thirty-Four Thousand and no/100 (\$34,000.00) and other good and valuable considerations, the receipt and sufficiency of which are hereby acknowledged, that, **Paul Richard Roberts, as executor of the estate of Laura Lou Whaley Roberts Leighton**, hereinafter called "Grantors", does hereby GRANT, BARGAIN, SELL AND CONVEY unto **C. J. Miske**, hereinafter called "Grantees" for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 7 according to the survey of Roberts Subdivision in the corporate limits of Montevallo, Alabama as recorded in Map Book 5, Page 109, and Map Book 6, Page 2, in the Probate Office of Shelby County, Alabama.

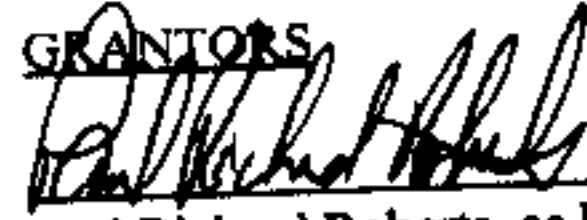
This conveyance is subject to all easements, rights-of-ways and restrictions of record, if any, affecting said property.

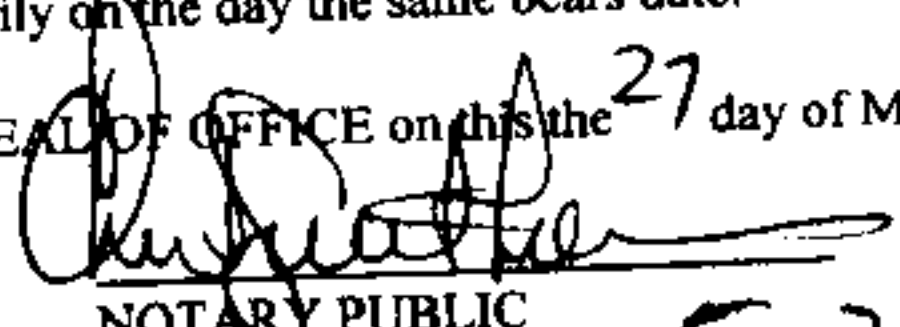
