Subject to:

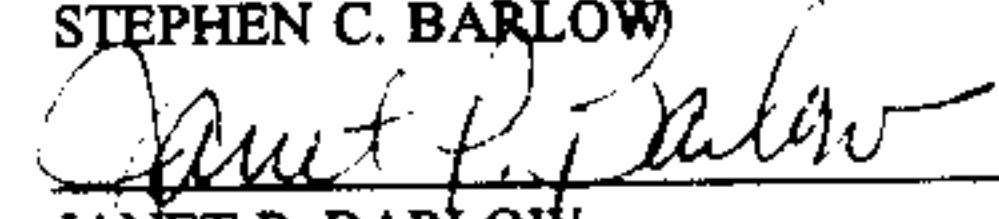

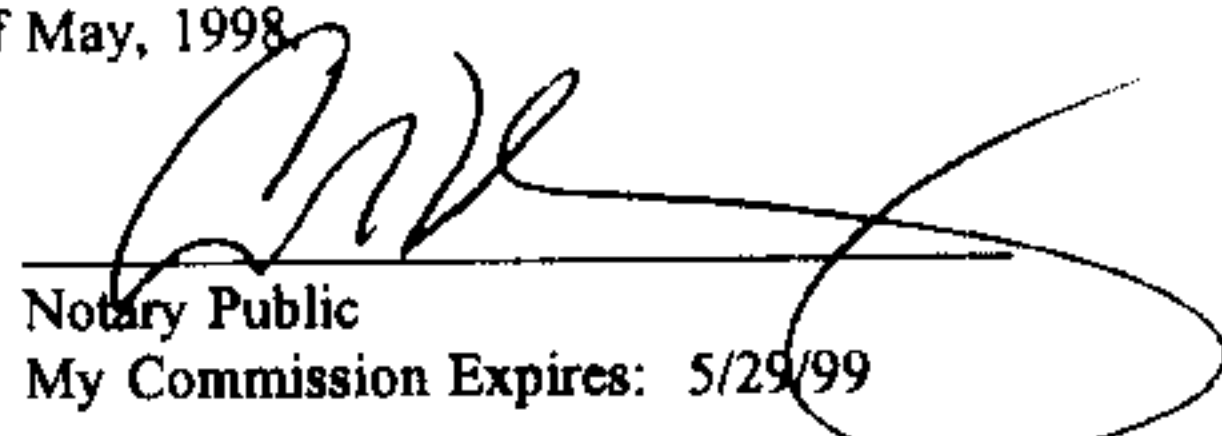
