KNOW ALL MEN BY THESE PRESENTS, That in consideration of TWO HUNDRED EIGHTY-EIGHT THOUSAND SEVEN HUNDRED AND NO/100 DOLLARS (\$288,700.00) to the undersigned grantor, DENMAN CONSTRUCTION CO., INC., a corporation, (herein referred to as GRANTOR), in hand paid by the GRANTEEES herein, the receipt of whereof is acknowledged, the said GRANTOR does by these presents grant, bargain, sell, and convey unto RUSSELL P. VANSANDT and DONNA P. VANSANDT (herein referred to as GRANTEEES) as joint tenants, with right of survivorship, the following described real estate, situated in Shelby County, Alabama:
