


The land referred to in this Policy is described as follows:

A part of the SE  $\frac{1}{4}$  of the NE  $\frac{1}{4}$  of Section 33, Township 17 South, Range 1 East, Shelby County, Alabama, more particularly described as follows:

Commence at an iron pin found, locally accepted to be the Northwest corner of the SE  $\frac{1}{4}$  of the NE  $\frac{1}{4}$  of said Section 33, Township 17 South, Range 1 East, and run thence South  $89^{\circ} 22' 05''$  East along the North line of said  $\frac{1}{4}$  -  $\frac{1}{4}$  section a distance of  $26^{\circ} 23' 0''$  to the Easterly right of way of Hilltop Road, said point being the point of beginning of the within described tract, thence South  $08^{\circ} 32' 17''$  West along said right of way a distance of 79.15 feet; thence South  $04^{\circ} 37' 30''$  West along said right of way a distance of 126.01 feet; thence South  $06^{\circ} 47' 52''$  West along said right of way a distance of 30.0 feet to an iron pin found at the intersection of said Easterly right of way of Hilltop Road and the Northerly right of way of Shelby County Highway #101; thence North  $86^{\circ} 34' 22''$  East along said right of way a distance of 263.46 feet to an iron pin found, thence Northeasterly along the arc of a curve and said right of way a distance of 624.94 feet to an iron pin set, said curve having a radius of 1843.01 feet, a central angle of  $19^{\circ} 25' 42''$ , a chord bearing of North  $76^{\circ} 51' 31''$  and a chord distance of 621.95 feet, thence North  $00^{\circ} 37' 55''$  East a distance of 67.20 feet to an iron pin set on the North line of said SE  $\frac{1}{4}$  of the NE  $\frac{1}{4}$  of Section 33, Township 17 South, Range 1 East, thence North  $89^{\circ} 22' 05''$  West along said North line a distance of 843.98 feet back to the point of beginning.
