CERTIFICATE OF TERMINATION

Comes now the undersigned to state the following under oath after being duly sworn:

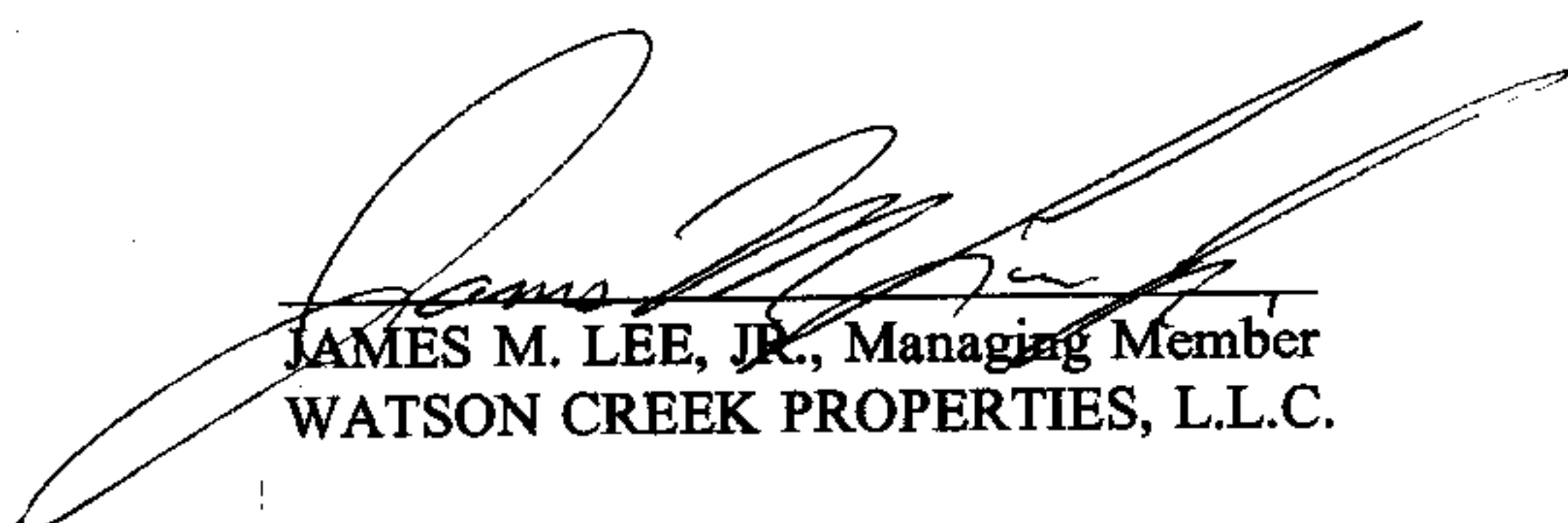
1) My name is James M. Lee, Jr., and I am the Managing Member of Watson Creek Properties, L.L.C., which is the Successor to James M. Lee, Sr.'s (also known as Milford Lee) limited partnership in Northwest Calera, Limited Partnership. The Partnership was formed on April 16, 1982, and recorded in Partnership Book 2, Page 118, of the Probate Records of Jefferson County, Alabama. James M. Lee, Sr., is deceased, his will being probated in Book 103, page 955, in the Probate Office of Shelby County, Alabama, as Case Number 32-252. Said will named Virginia Ruth L. Young, Jane Janell L. Rhodes, Linda Sue L. Vise, Jonna Kay Ali and James M. Lee, Jr. as heirs. A Statutory Warranty Deed from Virginia Ruth L. Young, as Executrix and Personal Representative of the Estate of James M. Lee, Sr. to the heirs named above was recorded in Instrument #1995-15408, in the Probate Office of Shelby County, Alabama. Virginia Ruth L. Young, Jane Janell L. Rhodes, Linda Sue L. Vise, Jonna Kay Ali, and James M. Lee, Jr. conveyed an undivided 12.5% interest in Northwest Calera, an Alabama Limited Partnership to Watson Creek Properties, L.L.C. by Warranty Deed recorded in Instrument #1998-04153, in the Probate Office of Shelby County, Alabama.

2) This partnership expired fifteen (15) years from the date of April 16, 1982, and I am a partner by virtue of being an original Partner or a successor in interest to a partnership interest.

3) I hereby authorize Charlotte Poe to be constituted and appointed as my attorney in fact for me with the power to act in my name and on behalf of me to wind up the affairs of NORTHWEST CALERA, LIMITED PARTNERSHIP, pursuant to Section 10-9A-142 Code of Alabama (1975) and to execute any needed documents in order to convey my interest, whatever interest it may be, to the purchasers of the parcel described in Exhibit "A" to this Certificate.

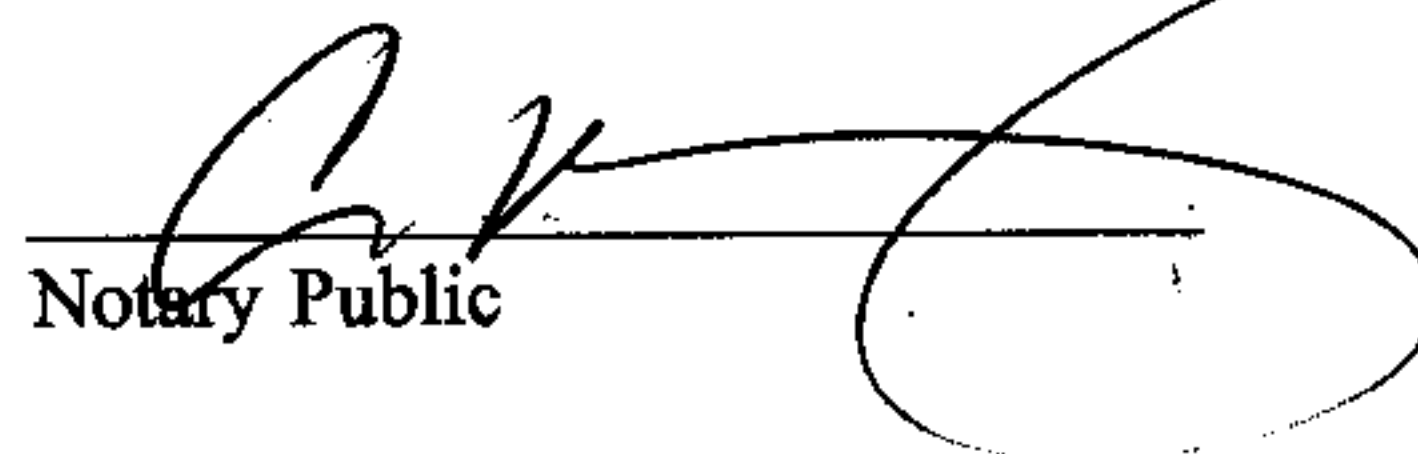
