A part of the NE 1/4 of the NW 1/4 and the NW 1/4 of the NE 1/4 of Section 1, Township 24 North, Range 15 East, Shelby County, Alabama more particularly described as follows:

Commence at the SE corner of the NE 1/4 of the NW 1/4 of Section 1, Township 24 North, Range 15 East; thence run N 87 degrees 38 minutes 00 seconds W along the S line of said quarter-quarter section for a distance of 51.98 feet to the 397' contour of Lay Lake; thence run N 12 degrees 57 minutes 00 seconds E along said contour for a chord distance of 741.68 feet to the point of beginning. Said point lying at the intersection of the 3977 contour and an unnamed branch; thence run N 40 degrees 32 minutes 23 seconds W for a distance of 71.22 feet; thence run S 37 degrees 34 minutes 17 seconds W for a distance of 57.17 feet; thence run S 46 degrees 04 minutes 17 seconds W for a distance of 104.83 feet; thence run N 56 degrees 23 minutes 43 seconds W for a distance of 164.8 feet; thence run N 39 degrees 55 minutes ll seconds E for a distance of 392.06 feet; thence run S 74 degrees 19 minutes 54 seconds E for a distance of 228.11 feet; thence run S 29 degrees 42 minutes 00 seconds W along an unnamed creek for a distance of 179.78 feet; thence run S 38 degrees 41 minutes 00 seconds W along an unnamed creek for a distance of 141.19 feet to the point of beginning.
