

CORPORATION WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS:

That in consideration of THREE HUNDRED SIXTY NINE THOUSAND EIGHT HUNDRED NINETY ONE and 00/100 DOLLARS (\$369,891.00) to the undersigned grantor, **KEN UNDERWOOD CLASSIC HOMES, INC.**, (hereinafter "grantor"), in hand paid by the grantee herein, the receipt whereof is acknowledged, grantor, does grant, bargain, sell and convey unto **JON H. AUERBACH and TANYA L. AUERBACH**, ("grantee"), as joint tenants with rights of survivorship, all of its interest in the following described real estate, situated in Shelby County, Alabama:

Lot 78, according to the Survey of the Final Record Plat of Greystone Farms, Milner's Crescent Sector, Phase 3, as recorded in Map Book 23 page 71 in the Probate Office of Shelby County, Alabama.

\$357,341.00 of the consideration is from a purchase money first mortgage.
