**KNOW ALL MEN BY THESE PRESENTS** that, the undersigned, as incorporators of a corporation under the Code of Alabama, adopt the following Articles of Incorporation for such corporation:

**FIRST:** The name of the corporation is **HOMELAND COMPUTER SYSTEMS, INC.**

**SECOND:** The period of duration is perpetual.

**THIRD:** The purposes for which this corporation is formed are: 1.) The operation of a computer service and sales company, and 2.) to engage in any lawful act or activity for which corporations may be organized under the Alabama Business Corporation Act.

The foregoing clauses shall be construed as the objects and purposes of the corporation in addition to those powers specifically conferred upon the corporation by law, and it is hereby expressly provided that the foregoing specific enumeration of powers shall be held to limit or restrict in any manner the powers of the corporation otherwise granted by law.

**FOURTH:** The aggregate number of shares which the corporation shall have authority to issue is One Hundred (100) of the par value of Ten Dollars (\$10.00) per share.
