That no right, title or interest in or to the mortgaged real estate, or any part thereof, shall be sold, trensferred, essigned, conveyed, mortgaged or encumbered by a lien at any time prior to the payment in full of the indebtedness(es) secured hereby without first obtaining the prior written consent and approval of Mortgages which consent and approval shall be within Mortgages's sole discretion; that in the event of any violation of this provision, the entire unpaid belance of the indebtedness(es) secured hereby, together with all interest thereon, shall become due and payable immediately at the option of Mortgages without notice to Mortgagor, and shall be recoverable by Mortgages forthwith or at any time thereafter without stay of execution or other process and failure of Mortgagor to pay all monies to Mortgages secured by this mortgage shall be an act of default entiting Mortgages to foreclose this mortgage in accordance with the terms hereof.
- 18. That it is the intent of the Mortgagor and Mortgagee to secure any and ell indebtednessies) of said Mortgagor to Mortgagoe, now existing or hereafter arising, due or to become due, absolute or contingent, liquidated or unliquidated, direct or indirect, and this mortgage is intended and does secure, not only the indebtedness hereinabove specifically referred to, but also any and all other debts, obligations and liabilities of said Mortgagor to said Mortgagee, whether now existing or hereafter arising, and any and all extensions or renewals of same, or any part thereof, at any time before actual satisfaction and cancellation of this mortgage in the Probate Office where recorded, and whether the same be evidenced by promissory note, upon account, endorsement, guaranty agreement, pledge agreement, or otherwise; that it is expressly agreed that any indebtedness at any time secured hereby may be extended, rearranged or renewed and that any part of the security herein described may be waived or released without in anyware altering, varying or diminishing the force, effect or lien of this mortgage; and this mortgage shall continue as a first lien on all of the real extete and other property and rights covered hereby and not expressly released untiliable sums with interest and charges hereby secured are fully paid, and no other property and rights covered hereby and not expressly released untiliable sums with interest and charges hereby secured are fully paid, and no affected by the execution of this mortgage; and no security subsequently taken by Mortgagee or other holder or holders of said indebtednessies) shall in any manner be impaired or any manner impair or affect the security given by this mortgage; and all security for the payment of said indebtednessies) or any part thereof shall be taken, considered and held as cumulative.

That Mortgagor agrees to faithfully perform all the covenants of the lessor or landlord under present and future lesses affecting the mortgaged real estate, and neither do nor neglect, nor permit to be done, anything which may diminish or impair their value, or the rents provided for therein, or the interest of the lessor or of the Mortgages therein or thereunder.
- 21. That Mortgagor shall furnish to Mortgagee within

That if the indebtedness evidenced by the note specifically referred to hereinabove is being edvanced by Mortgages to Mortgagor under the terms and provisions and in accordance with a loan agreement or construction loan agreement ("egreement"), the terms end provisions of said agreement are hereby incorporated by reference as part of this mortgage as if fully set out herein, and any default in the performance of the provisions thereof, or any contract or agreement between Mortgagor and Mortgagee, shell constitute a default hereunder entitling Mortgages to exercise the immedies provided herein, including the right to foreclose this mortgage in accordance with the terms hereof; that each FUTURE ADVANCE advanced by Mortgages to Mortgagor is being advanced in accordance with an agreement dated. Jul. 2, 1998 and is secured by this mortgage.
- 23. That in the event this mortgage is second and subordinate to any prior mortgage(s) and in the event the Mortgagor should fail to make any payments which become due on said prior mortgage(s), or should default in any of the other terms, provisions and conditions of said prior mortgage(s) given. Then such default under the prior mortgage(s) shall constitute an event of default under the terms and provisions of this mortgage, and the Mortgagee herein may, at its option, declare the entire indebtedness(es) secured by this mortgage immediately due and payable and if payment is not promptly made, then declare this mortgage in default and subject to foreclosure, provided that the Mortgagee herein may, at its option, make, on behalf of Mortgagor, any such payments which become due on said prior mortgage(s), or incur any such expense or obligations on behalf of Mortgagor, in connection with the said prior mortgage(s), in order to prevent the foreclosure of said prior mortgage(s), and all such amounts so expended by the within Mortgagee on behalf of said Mortgagor shall become a debt to the Mortgagee and shall be secured by this mortgage and shall bear interest from the date of payment at the maximum legal rate of interest from time to time permitted by the laws of the State of Alabame, and shall be at once due and payable, entitling the Mortgagee to all of the rights and remedies provided herein, including, at Mortgagee's option, the right to foreclose this mortgage.
