SCHMIDT and wife, JEAN H. SCHMIDT, (herein referred to as grantors, whether one or more) do grant, bargain, sell, and convey unto **ROBERT E. NIEBUHR and KATHERINE E. NIEBUHR** (herein referred to as GRANTEES) as joint tenants, with right of survivorship, the following described real estate, situated in SHELBY County, Alabama:


\$176,700.00 of the consideration was paid from the proceeds of a mortgage loan closed simultaneously herewith.


