

SUBORDINATION AGREEMENT

STATE OF ALABAMA, Shelby COUNTY:

This Subordination Agreement, made and entered into on this the 24th day of June, 1998, by and between:

UNIVERSITY FEDERAL CREDIT UNION

as party of the First Part, and:

NATIONAL CITY MORTGAGE CO.

as party of the Second Part.

WITNESSETH:

THAT, WHEREAS, CHARLES H. SELF, JR. and LINDA S. SELF, has an outstanding lien in favor of: **UNIVERSITY FEDERAL CREDIT UNION**

dated the 4th day of May, 1995, and recorded in the Probate Office of Shelby County, Alabama, on certain real estate described therein to secure an indebtedness of \$ 11,511.50, and said lien is in full force and effect; and,

WHEREAS, CHARLES H. SELF, JR. and LINDA S. SELF, has made an application to the Party of the Second Part for a loan in the sum of \$225000.00 and said Party of the Second Part is willing to make said loan to the said CHARLES H. SELF, JR. and LINDA S. SELF, provided hereshetthey furnish it with a mortgage on the lands described in the aforesaid lien, and the said Party of the First Part subordinate the above-described lien and make the same second and subservient to the mortgage of NATIONAL CITY MORTGAGE CO.; and

WHEREAS, the said Party of the First Part is willing to subordinate its said lien and make the lien second and subservient to the mortgage of the said Party of the Second Part as an inducement to it to make said loan.

NOW, THEREFORE, in consideration of the premises and the further consideration of the sum of \$ 1.00 cash, in hand paid, the Party of the First Part by the Party of the Second Part, the receipt of which is hereby acknowledged, the said Party of the First Part does hereby agree that the lien of CHARLES H. SELF, JR. and LINDA S. SELF, dated May 4, 1995, and recorded in Probate Office of Shelby County, Alabama in Volume 1995 at Page 12626, to secure the said lien shall be subordinate to the mortgage of NATIONAL CITY MORTGAGE CO..

IT IS FURTHER agreed that should CHARLES H. SELF, JR. and LINDA S. SELF default in the payments under the terms of the real estate mortgage to Party of the Second Part, the said Lender agrees to notify Party of the First Part of said default prior to taking legal action.
