KNOW ALL MEN BY THESE PRESENTS, That in consideration of TWO HUNDRED THIRTY-FOUR THOUSAND FIVE HUNDRED DOLLARS AND NO/100's (\$234,500.00) to the undersigned grantor, DAVID ACTON BUILDING CORPORATION, a corporation, (herein referred to as GRANTOR), in hand paid by the GRANTEES herein, the receipt of whereof is acknowledged, the said GRANTOR does by these presents grant, bargain, sell, and convey unto JOHN M. KELLY and LISA M. KELLY (herein referred to as GRANTEES) as joint tenants, with right of survivorship, the following described real estate, situated in SHELBY County, Alabama:

Lot 307, according to the Survey of Yellowleaf Ridge Estates, Third Sector, as recorded in Map Book 22, Page 114, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.


