ADAMS and wife, GERALDINE R. ADAMS, (herein referred to as grantors, whether one or more) do grant, bargain, sell, and convey unto JAMES C. THOMPSON and ELAINE G. THOMPSON and HELEN O. BAGWELL (herein referred to as GRANTEES) as joint tenants, with right of survivorship, the following described real estate, situated in SHELBY County, Alabama:


