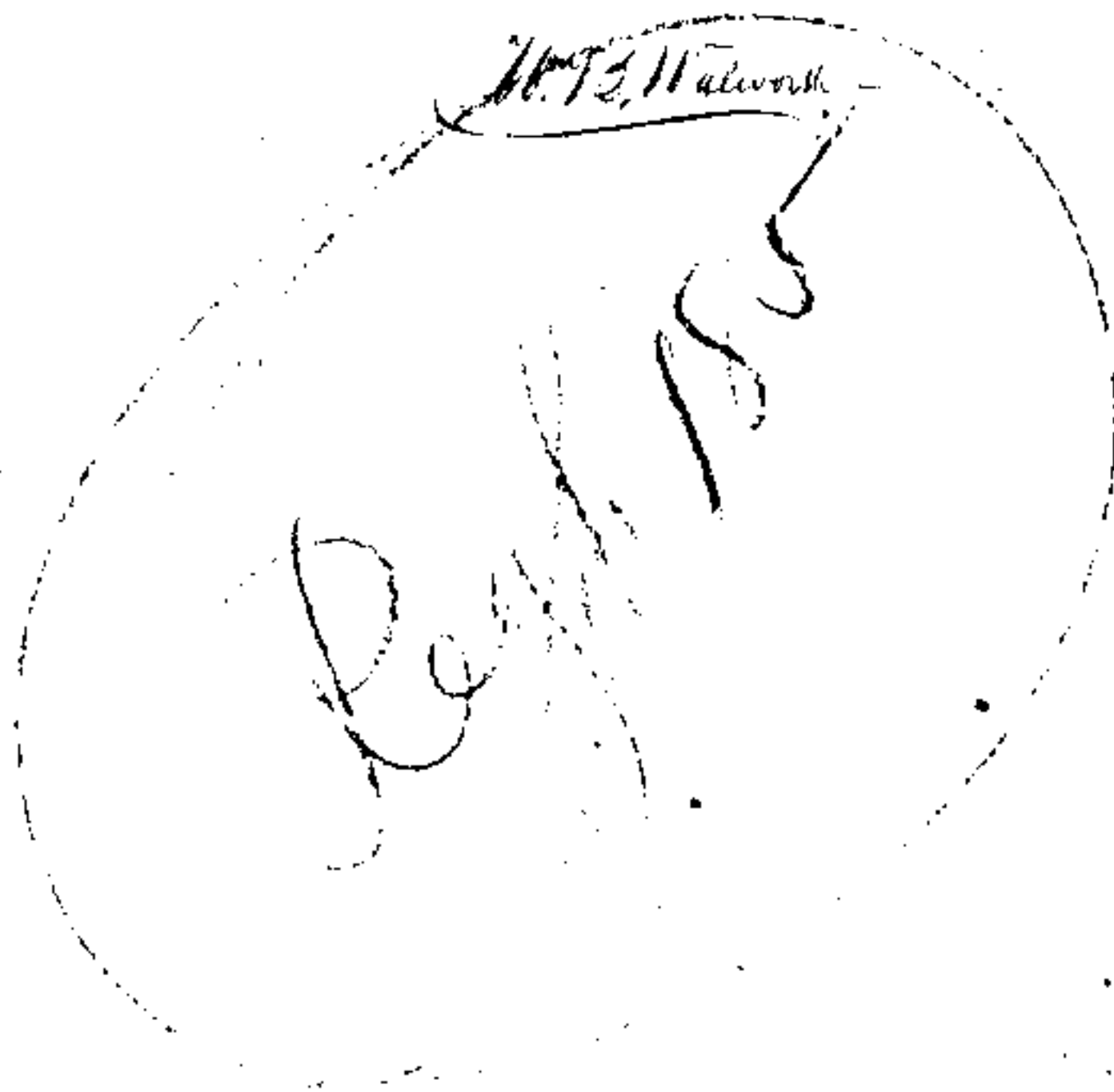

I, Joseph Wilson acting, COMMISSIONER OF THE GENERAL LAND OFFICE,
do hereby certify, that the foregoing on pages 1 to 5
inclusive, is a true and correct list of the tracts of land selected by the agent of the State
of Alabama, OUTSIDE OF THE SIX, AND WITHIN THE FIFTEEN MILE LIMITS, under the
act of Congress approved 3^d June 1856 entitled "An act granting public
lands in alternate sections to the State of Alabama to aid in the
construction of certain Rail Roads in said State", within the district
of lands subject to sale at Tuscaloosa Alabama
the said selections being from the lands of the United States, in the alternate
numbered by odd numbers, most contiguous to the tier of section
width on each side of the Rail Road from "1st
State, and to
Road

within or

legally sold, or to which the right of Pre-emption had legally accrued,
at which the rights of the State inured under said grant; and they are now submitted
for the approval of the Secretary of the Interior, in accordance with the requirements
of said act of 3^d June 1856, subject to all its conditions, and to any valid
interfering rights which may exist to any of the tracts embraced in the foregoing list.
