Commence at the SE corner of the NW 1/4 of the SW 1/4 of Section 14, Township 21 South, Range 3 West, Shelby County, Alabama and run thence northerly along the East line of said 1/4-1/4, 523.28 feet to a point; thence turn 87 deg. 00 min. 20 sec. to the left and run westerly 277.89 feet to a point; thence turn 00 deg. 18 min. 54 sec. to the right and continue westerly 155.35 feet to a steel pin corner and the point of beginning of the property being described; thence continue last described course 198.46 feet to a steel pin corner on the East line of Alabama Highway No. 119; thence turn 97 deg. 41 min. 13 sec. left and run southerly along said margin of said Highway 4.61 feet to a concrete highway monument at the P.C. of a curve to the left; thence turn 00 deg. 56 min. 35 sec. right to chord and run southerly along the chord of said curve a chord distance of 161.99 feet to a steel pin corner; thence turn 83 deg. 23 min. 41 sec. left from chord and run easterly 206.28 feet to a steel pin corner; thence turn 99 deg. 18 min. 51 sec. left and run northerly 167.22 feet to the point of beginning; being situated in Shelby County, Alabama.
