recorded in Inst. [#] 1997-31444, in the Office of the Judge of Probate of Shelby County, Alabama, the following described property:

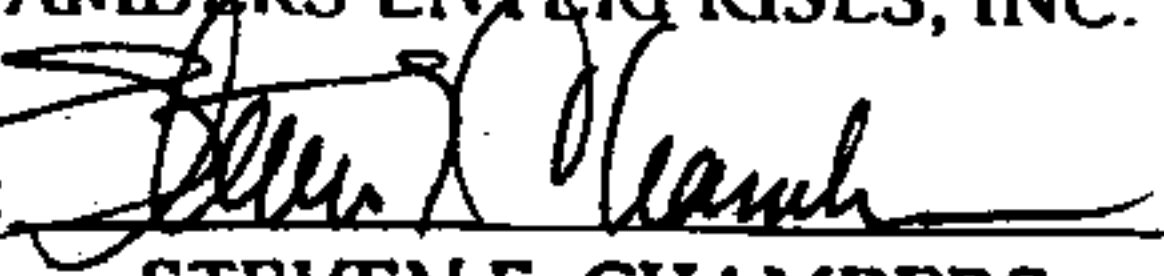

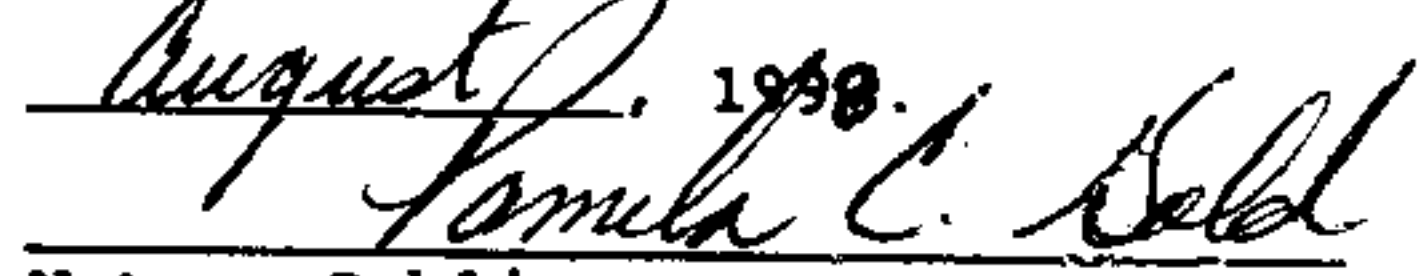
