KNOW ALL MEN BY THESE PRESENTS, That in consideration of **TWO HUNDRED NINETY-ONE THOUSAND SIX HUNDRED DOLLARS AND NO/100's (\$291,600.00)** to the undersigned grantor, **KEN UNDERWOOD CLASSIC HOMES, INC.**, a corporation, (herein referred to as **GRANTOR**), in hand paid by the **GRANTEES** herein, the receipt of whereof is acknowledged, the said **GRANTOR** does by these presents grant, bargain, sell, and convey unto **RONALD S. MOORE and KAY H. MOORE** (herein referred to as **GRANTEES**) as joint tenants, with right of survivorship, the following described real estate, situated in **SHELBY County, Alabama**:

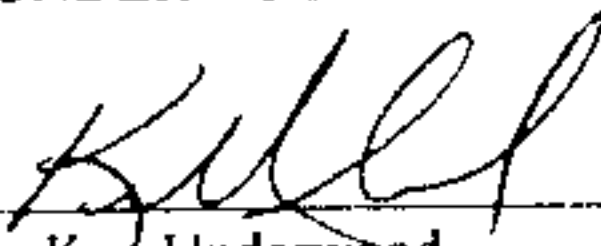
\$227,150.00 of the consideration was paid from the proceeds of a mortgage loan closed simultaneously herewith.

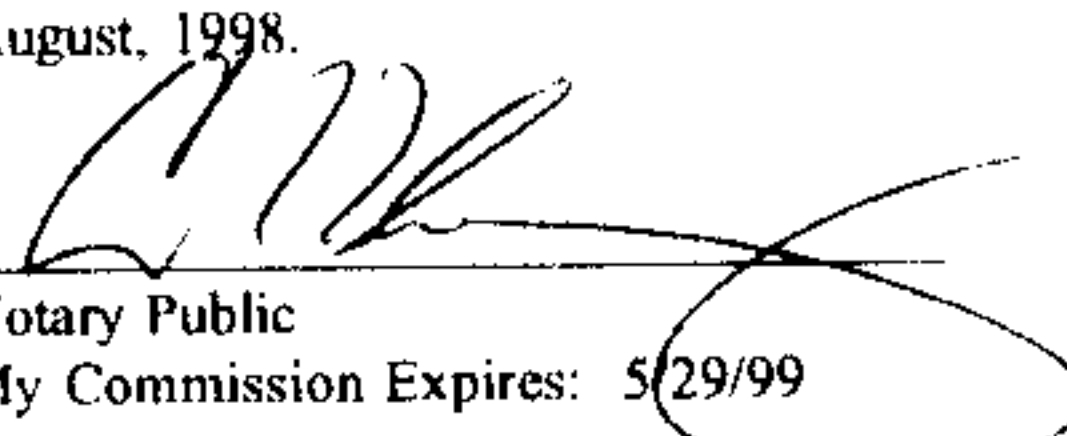
