KNOW ALL MEN BY THESE PRESENTS:

That **THE WATER WORKS AND SEWER BOARD OF THE CITY OF BIRMINGHAM**, a public corporation organized and existing under the laws of the State of Alabama (herein called the "Board"), makes the following recital of facts as the basis for this conveyance:

a. The Board now owns and operates certain water reservoirs and filtration plants and water supply, transmission and distribution systems and various related properties (herein together called the "Water System") and certain sewage treatment plants and wastewater collection systems (herein together called the "Sewer System") located within Jefferson County and certain adjacent counties.

b. The Board was incorporated pursuant to authorization by the governing body of the City of Birmingham (herein called the "City"). Under the Board's enabling statute, when all bonds of the Board that are payable from the revenues derived from the operation of the Water System and the Sewer System (herein together called the "Systems") have been paid in full, then the Systems shall become the property of the City and title to the Systems shall thereupon immediately vest in the City.

c. The City has advised the Board (i) that the City has initiated a program to identify and pursue possible methods for utilizing existing and anticipated resources of the City to create and provide substantial long-term financial support for the improvement of public education within the City, (ii) that the City has determined that a significant amount of money for long-term financing of public education could be obtained through a sale and transfer of the Systems (or various components thereof) to one or more private entities, and (iii) that the planning and implementation

required for such a sale and transfer of the Systems can be undertaken and completed more efficiently and effectively if the Systems are transferred and conveyed to the City at this time.

d. The immediate transfer and conveyance of the Systems to the City, pursuant to the City's request and for the purpose described in the preceding subparagraph (c), will be consistent with the intent of the Board's enabling statute.

e. The Board has heretofore incurred certain indebtedness from time to time in connection with its ownership, operation and expansion of the Systems, including various series of bonds payable from revenues from the Systems (herein together called the "Outstanding Bonds").

f. The City has offered to take possession of the Systems and to assume the indebtedness of the Board evidenced by the Outstanding Bonds, and it is appropriate, desirable and in the best interests of the residents of the City and the surrounding territory for the Board to convey the Systems to the City.

g. The Board of Directors of the Board has agreed to the City's request that the Systems, and all such other properties and assets of the Board, now be conveyed to the City, subject to the approval of the governing body of the City.

h. The City (by Ordinance No. 98-148 duly adopted by its governing body on September 1, 1998) has approved such conveyance and transfer and has found, ascertained, determined and declared that it would be in the public interest and advantageous to the City and its inhabitants if the Systems, all properties and interests in properties and all other funds and assets relative to the ownership or operation of the Systems and all other assets of the Board, should be transferred and conveyed to the City.

NOW, THEREFORE, in consideration of Five and No/100 Dollars (\$5.00) and other good and valuable consideration, the receipt and sufficiency of which consideration are hereby acknowledged, the Board does hereby

(A) remise, release and quitclaim to the City all right, title and interest of the Board in or to all the real, mixed and personal property that constitutes the Systems, including, without limitation, (i) all of its right, title and interest to and in the Water System owned by the Board and all real, mixed, tangible and intangible properties and assets that form a part of or pertain to the Water System, including, without limitation, all lands, buildings, improvements, appurtenances, leases, rights-of-way, crossing agreements, easements, permits, licenses and other interests in, or rights with respect to, land that constitutes part of or appertains to or is used in connection with the operation of and form a part of the Water System and all furniture, fixtures, equipment and other personal property used in connection with the operation of and forming a part of the Water System, including, without limitation, the real property interests and land described in *Exhibit A* attached hereto and constituting a part hereof and the improvements, buildings, equipment, fixtures, furnishings and other property, described in *Exhibit B* and *Exhibit C* attached hereto and

constituting a part hereof; and (ii) all right, title and interest of the Board in or to the Sewer System owned by the Board and all of the Board's other real, personal, mixed, tangible and intangible properties and assets that form a part of any such sewer system, including, without limitation, all lands, buildings, improvements, appurtenances, leases, rights-of-way, crossing agreements, easements, permits, licenses and other interests in, or rights with respect to, land that constitutes part of or appertains to or is used in connection with the operation of and form a part of any sanitary sewer systems owned by the Board, including, without limitation, the real property interests described in *Exhibit A* attached hereto and constituting a part hereof and the improvements, buildings, equipment, fixtures, furnishings and other property, described in *Exhibit B* and *Exhibit C* attached hereto and constituting a part hereof;

(B) to the extent not conveyed or assigned elsewhere herein, remise, release and quitclaim to the City all right, title and interest of the Board in or to the property described in *Exhibit A* attached hereto and constituting a part hereof and *Exhibit C* attached hereto and constituting a part hereof and all other real property located in the State of Alabama or real property interests in which the Board has an interest, whether adequately or specifically described herein or not, and all fixtures, buildings and improvements thereon or used in connection therewith, and all personal property of the Board, tangible or intangible;

(C) convey, transfer, assign and set over to the City the following:

(i) all contract rights, moneys, tolls, rents, accounts receivable, choses in action, franchises, general intangibles, documents, instruments, insurance policies and other general intangibles that have been acquired and are now held by the Board, whether as a result of its ownership or operation of the Systems or otherwise and all revenues, issues, earnings, income and profits from the Systems;

(ii) all right, title and interest of the Board in, to and under any and all licenses, easements, rights-of-way, crossing agreements, franchises, privileges, immunities, course of dealing, and permits under or pursuant to which it is authorized to engage, whether directly or indirectly, in the construction, acquisition and operation of the Systems, including, without limitation, the operation of the Systems in any incorporated municipality and in any nearby unincorporated territory;

(iii) all right, title and interest of the Board in, to and under any and all contracts between the Board and any other person, firm or corporation relating to, or in connection with, the operation of the Systems or any part thereof, including, without limitation, any contracts, agreements, arrangements or contract rights with respect to service of water or sewer customers presently served by the Systems;

(iv) all cash on hand and on deposit (including cash on deposit in bank accounts), notes receivable, customers' security deposits, supplies and other prop-

erties held for sale in the ordinary course of business or for use or consumption in the operation of the Systems, and all revenues, earnings, income and profit derived by the Board from the operation of the Systems or relating thereto; and

(v) all books and records related to the Systems.

TO HAVE AND TO HOLD unto the City forever.

The intent of this instrument is to convey all of the assets owned by the Board whether specifically or correctly described herein or not to the extent the same are contractually and legally transferable. From time to time, at the request of the City, without further consideration and within a reasonable amount of time after request is made, the Board shall execute and deliver such further instruments of conveyance, transfer and assumption as may be reasonably required or requested to evidence with more specificity or more accurately describe the assets conveyed herein to the City or to make warranties in connection therewith including, without limitation, warranty deeds, special warranty deeds, bills of sale, assignments, transfer of certificates of title and other instruments of conveyance and the Board shall take such other actions, including, without limitation, the obtaining of consents, authorizations and approvals to the actions contemplated hereby as may be necessary and advisable. The execution of or failure to execute additional instruments of conveyance or further assurances shall in no way impact or affect the validity of this conveyance or of such other instruments. To the extent that the transfer of any asset may require consent, authorization or approval by any third party, this conveyance is intended to be self-executing and shall be fully effective when such consent, authorization or approval is given without further action by the Board.

IN WITNESS WHEREOF, the Board has caused this Quitclaim Deed, Bill of Sale and Assignment to be executed in its name and behalf, has caused its official seal to be hereunto affixed and has caused this Quitclaim Deed, Bill of Sale and Assignment to be attested, all by its duly authorized officers, this 2nd day of September, 1998.
