ARTICLES OF ORGANIZATION

ARTICLE I

NAME

Concrete Designs and Coatings, L.L.C.

Must contain the words Limited Liability Company or L.L.C.

ARTICLE II

DURATION

The period of duration is 20 Years.

ARTICLE III

PURPOSES

The Limited Liability Company has been organized for the following purposes:

To perform waterproofing work on residential and commercial foundations and spray concrete finishes on surfaces.

ARTICLE IV
