AMENDMENT TO ACCOMMODATION MORTGAGE CERTIFIED SHELBY COUNTY JUDGE OF PROBATE

to secure indebtedness of the Borrower in the original principal amount of One Hundred Fifty Thousand and no/100 dollars (\$150,000.00) (the "Accommodation Mortgage").

B. The Borrower has requested the Lender extend additional credit and the Lender has agreed to extend additional credit, on the condition, among other things, the Mortgagor execute and deliver this Amendment to Mortgage.

NOW, THEREFORE, in consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree as follows:

AGREEMENT

1. Paragraph 2. of the Accommodation Mortgage is hereby modified to read:

Airport Marine, Inc. is or hereby will be justly indebted to Lender in the amount of Two Hundred Thousand and no/100 dollars (\$200,000.00) as evidenced by that promissory note of even date herewith.

2. Except as modified herein, the Accommodation Mortgage shall remain in full force and effect.

Nothing contained in this Amendment shall be deemed to constitute a novation of the Accommodation Mortgage nor impair any other credit documents, nor affect any of the rights, powers or remedies of the Lender thereunder nor constitute a waiver of any provision thereof, except as specifically set forth in this Amendment.
