WITNESSETH:

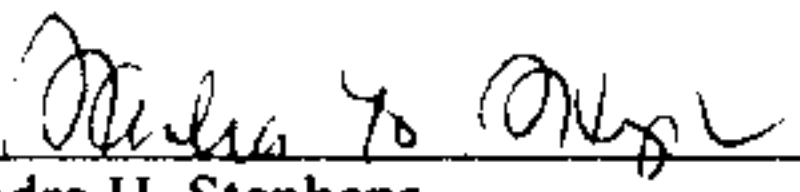

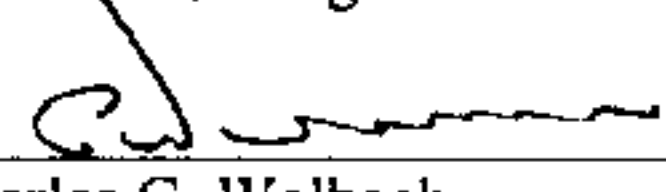
