ALABAMA FOREST PRODUCTS, INC. his agent, employees, and assign our interest in all trees,
regardless of size ~~and species~~ now standing and growing upon the following described lands, situated in the
County of Shelby County and State of Alabama, to-wit:

All merchantable pine trees:
on the properties described to-wit: See Attachments A & B
Approximately 33 acres in Secs 27 & 28, T24N, R15E
(1) NE 1/4, SE 1/4, Sec 28 (2) SW 1/4, SW 1/4, Sec 27

together with access to said timber and the right of ingress, egress, and regress for said ALABAMA
FOREST PRODUCTS, INC. agent, servants, contractors, employees, heirs, and assigns, over across, and along
said lands, and any other lands owned by US for the purpose of cutting, removing, and manufacturing said

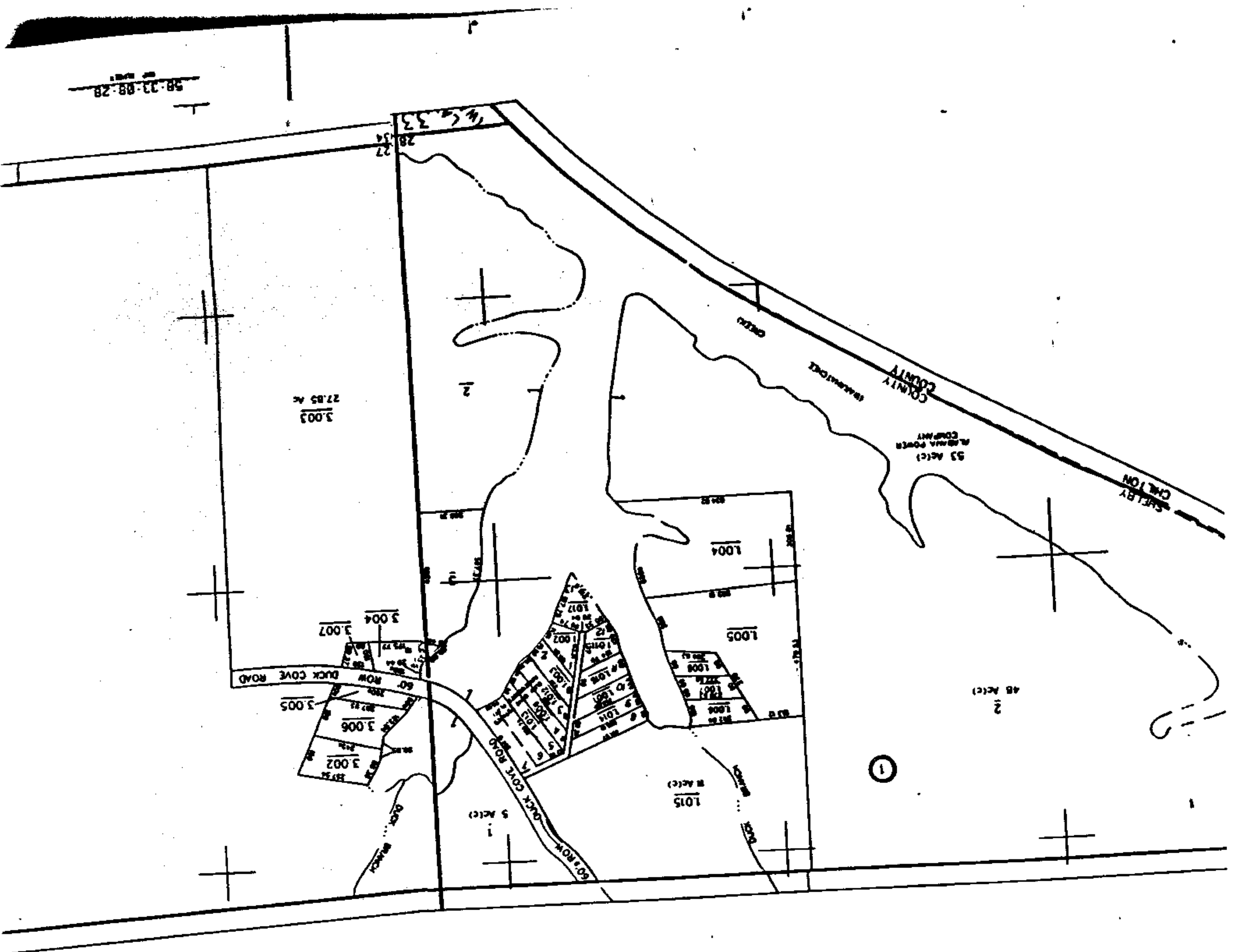
