**ARTICLES OF ORGANIZATION
OF
KEN UNDERWOOD PROPERTIES, L.L.C.**

Pursuant to the Provisions of Act No. 93-724 of the 1993 Alabama Legislature or the "Alabama Limited Liability Company Act", the undersigned hereby adopt the following Limited Liability Company Articles of Organization:

ARTICLE ONE: NAME

The name of the Limited Liability Company ("Company") is:

KEN UNDERWOOD PROPERTIES, L.L.C.

ARTICLE TWO: DURATION

The period of duration for the Company shall be perpetual, beginning on the date these Articles of Organization are filed by the Probate Judge of Shelby County.

ARTICLE THREE: PURPOSES

The members of the company expressly reserve the right to admit additional members under the terms and conditions set forth in the operating agreement.


ARTICLE SEVEN: MANAGEMENT


