

KNOW ALL MEN BY THESE PRESENTS: That I, Thelma G. Sirles, krtesdilentrotetizen of Jefferson County, Alabama, and over the age of nineteen years, being of sound mind and disposing memory, do hereby make, publish and declare this to be my Last Will and Testament, hereby revoking any other wills and codicils thereto heretofore made by me.

ITEM ONE

I direct that all of my just debts, including my funeral expenses and the expenses of my last illness, be paid by my Executor hereinafter named as soon after my death as is practicable.

ITEM TWO

I hereby give and bequeath unto my husband, Buford G. Sirles, the sum of One Thousand and no/00 Dollars (\$1,000,00).

ITEM THREE

All the rest and residue of my estate, whether real, personal or mixed, of whatever kind and character and wheresoever situated, I hereby give, devise and bequeath unto my daughter, Jane S. Glaser, to be hers absolutely and in fee simple, or in the event of her death prior to mine, to her lineal descendants in equal shares, per stirpes.

ITEM FOUR

I hereby appoint my husband, Buford G. Sirles, as Executor of this my Last Will and Testament. In the event my husband is unable or unwilling to serve, then I appoint my daughter, Jane S. Glaser, as alternate Executrix. I hereby exempt my said Executor, or alternate Executrix, as the case may be, from making bond or filing any inventory or final settlement of my estate in any court. I vest my said Executor or alternate Executrix with full power and authority to transfer, sell and convey any property, real, personal or mixed, which I might own at the time of my death, at such time and price and upon such terms and conditions as he or she may determine, and to do every other act and thing necessary or appropriate for the complete administration of my estate.
