PARCEL #1:

From a 2" pipe at the S.W. corner of Section 8, Township 20 South, Range 2 East, being the point of beginning of herein described parcel of land; run thence North along the West boundary of said Section 8 a distance of 665.00 feet to a 1/2" rebar; thence turn 90 degrees 13 minutes 17 seconds right and run 1335.31 feet to a 1/2" rebar on the Westerly boundary of Dead Hollow Road South (40' R.O.W. . ASSUMED); thence turn 89 degrees 32 minutes 49 seconds right and run 241.29 feet along said road boundary to a 1/2" rebar; thence turn 07 degrees 07 minutes 07 seconds right and run 426.59 feet along said road boundary to a 1/2" rebar on the South boundary of aforementioned Section 8, thence turn 83 degrees 20 minutes 04 seconds right and run 1285.14 feet to the point of beginning of herein described parcel of land.
