KNOW ALL MEN BY THESE PRESENTS, That in consideration of **THREE HUNDRED TWENTY-SEVEN THOUSAND NINE HUNDRED DOLLARS AND NO/100's (\$327,900.00)** to the undersigned grantor, **LEWIS INTEGRITY HOMES, INC.**, a corporation, (herein referred to as **GRANTOR**), in hand paid by the **GRANTEES** herein, the receipt of whereof is acknowledged, the said **GRANTOR** does by these presents grant, bargain, sell, and convey unto **MICHAEL L. HARRIS and JAN G. HARRIS** (herein referred to as **GRANTEES**) as joint tenants, with right of survivorship, the following described real estate, situated in **SHELBY County, Alabama**:

Lot 823, according to the Survey of Highland Lakes, 8th Sector, an Eddleman Community, as recorded in Map Book 23, Page 145, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.
