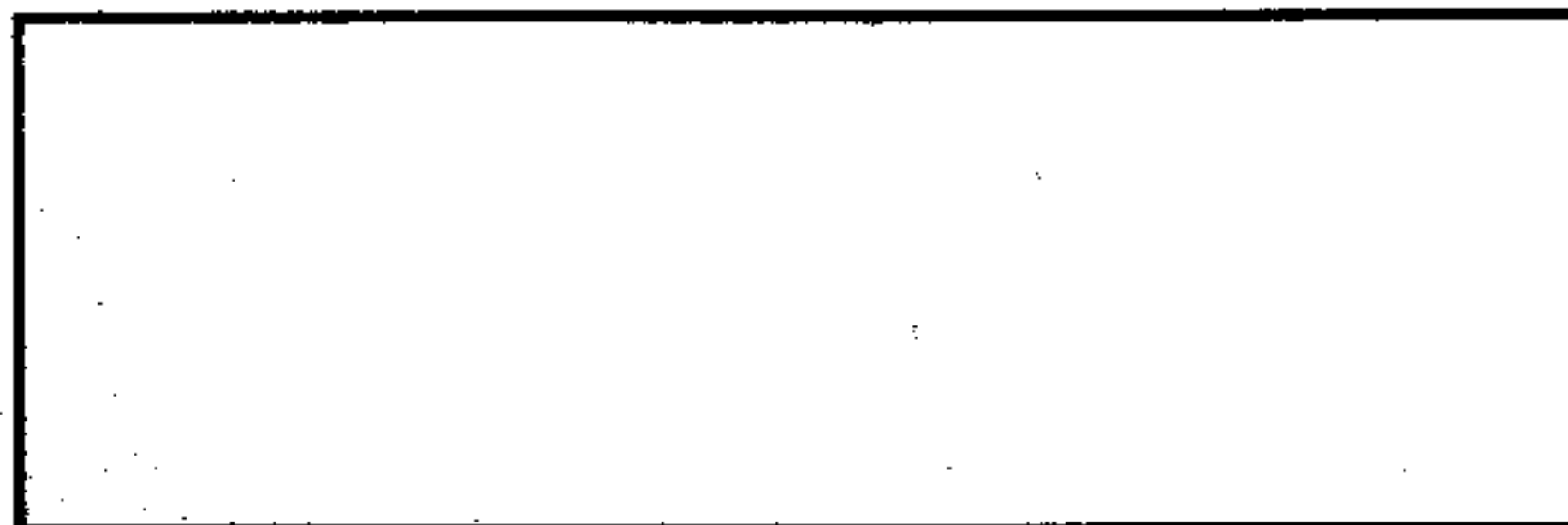
Specific description of property:

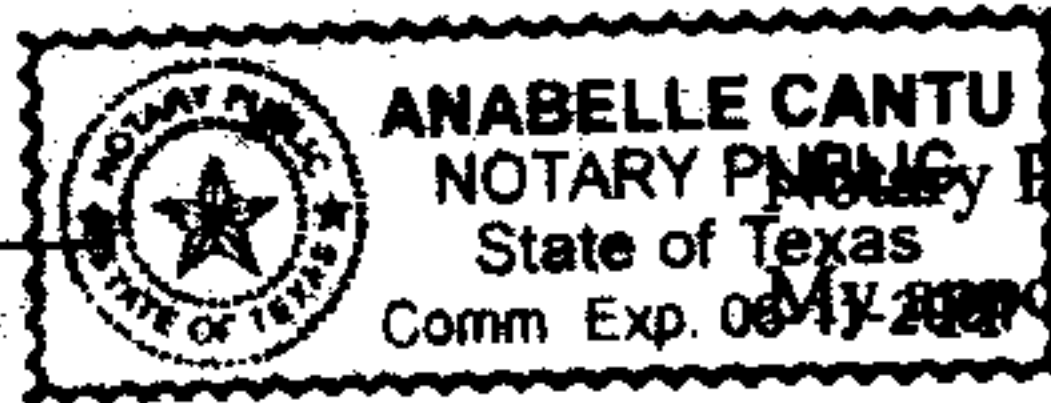
