KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of One Hundred Forty-Nine Thousand Nine Hundred and 00/100 Dollars (\$149,900.00) to the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged, DWG BUILDERS, INC. (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto CARL T. PEARSON and SHARON R. PEARSON, (herein referred to as "Grantee"), as joint tenants with rights of survivorship, the following described real estate situated in Shelby County, Alabama, to wit:

Lot 23, according to the Survey of Grande View Estates, Givianpour Addition to Alabaster, 2nd Addition, as recorded in Map Book 20, page 66, in the Probate Office of Shelby County, Alabama.
