## SUBORDINATION AGREEMENT

THIS SUBORDINATION AGREEMENT, made and entered into this the \_\_\_\_day of October, 1998, by and between First Commercial Bank, (hereinafter "First Commercial"), and Regions Bank, M.A. (hereinafter "Regions").
