

**SECOND AMENDMENT TO
ARTICLES OF ORGANIZATION
OF
GREYSTONE DEVELOPMENT COMPANY, L.L.C.**

Pursuant to the provisions of Ala. Code § 10-12-11 (1975), the undersigned hereby adopt the following amendments to the Articles of Organization of Greystone Development Company, L.L.C., an Alabama limited liability company:

1. **Name of Limited Liability Company.** The name of the limited liability company is Greystone Development Company, L.L.C. (the "Company").

2. **Date of Filing of Articles of Organization.** The Articles of Organization of the Company were filed in the Office of the Judge of Probate of Shelby County, Alabama (the "Probate Office") on July 26, 1995 as Instrument No. 1995-19707 and were amended by First Amendment to Articles of Organization dated as of December 13, 1995 (but effective as of July 14, 1995) which was recorded on February 20, 1996 as Instrument No. 1996-05493 in the Probate Office.

3. **Change of Name of Company.** Article I of the Articles of Organization is amended by deleting said Article I in its entirety and by substituting in lieu thereof the following:

"Name

The name of the limited liability company is Greystone Development Company, LLC (the "Company")."

4. **Initial Members.** Article V of the Articles of Organization of the Company is amended by deleting said Article V in its entirety and by substituting in lieu thereof the following:

5. **Managers.** Article VIII of the Articles of Organization of the Company is amended by deleting said Article VIII in its entirety and by substituting in lieu thereof the following:

"Manager"

The Company shall be managed by a manager who shall have the exclusive right to manage the affairs of the Company and to handle all matters arising in connection therewith. The manager shall be designated, appointed, elected, removed or replaced by the vote of a majority in interest of all members of the Company. The name and address of the initial manager of the Company, who shall serve as manager of the Company until its successor is elected, is:

6. **Effective Date.** Notwithstanding anything provided herein to the contrary, the parties hereto desire that the effective date of the terms and provisions of this Second Amendment as of November 1, 1998.

7. **Full Force and Effect.** Except as expressly modified and amended herein, all the terms and provisions of the Articles of Organization of the Company, as previously amended, shall remain in full force and effect.

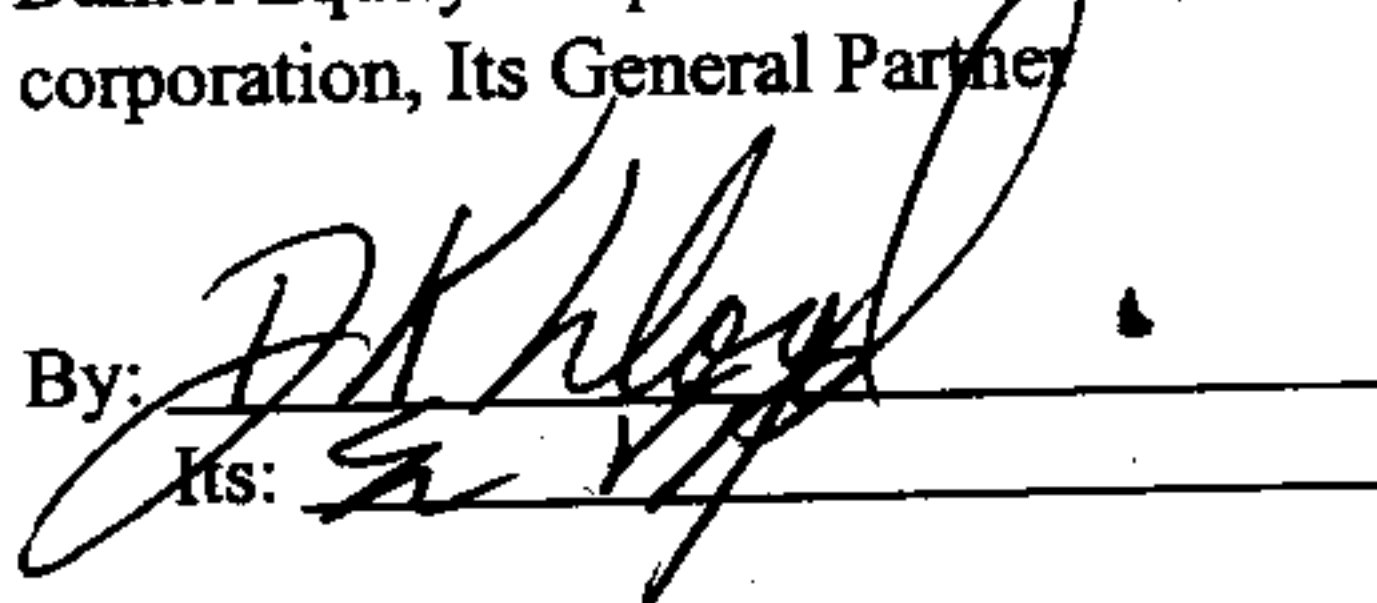
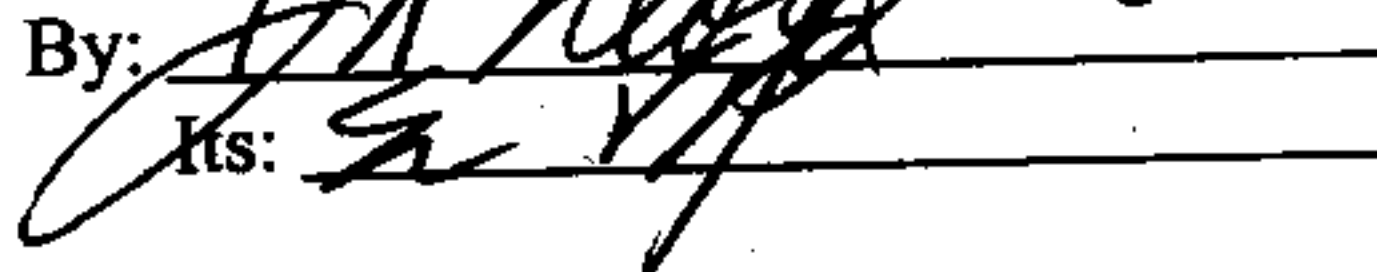

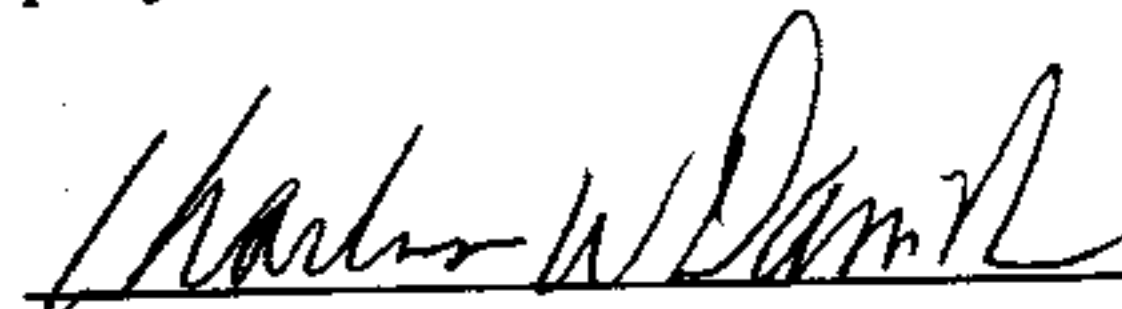
CONSENT OF WITHDRAWING MEMBER AND MANAGER

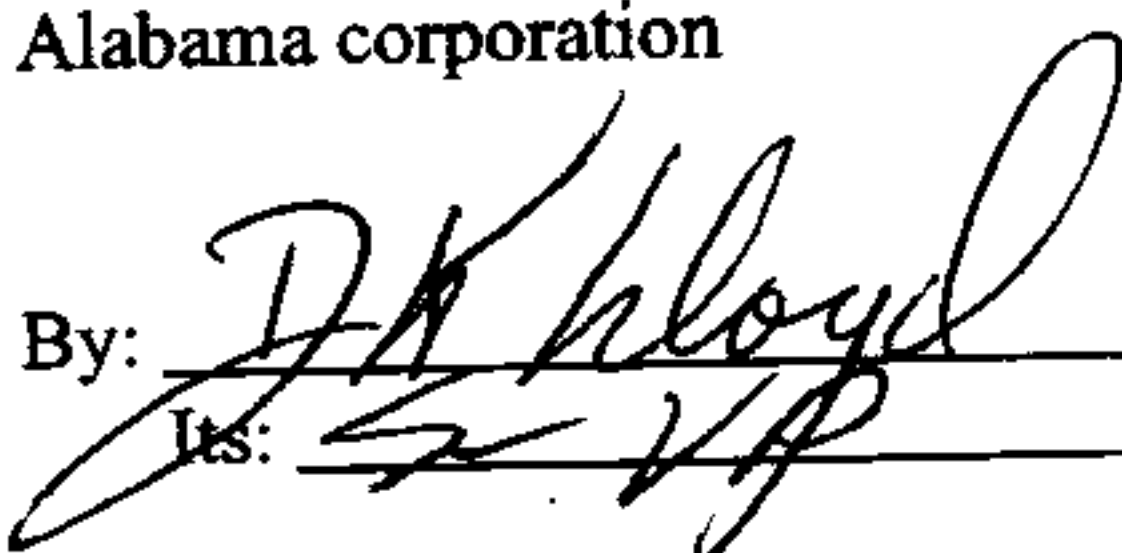

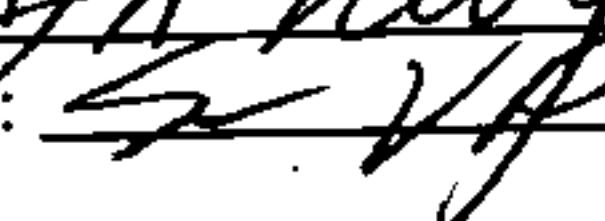
CONSENT OF MANAGER
