ADJUSTABLE RATE LOAN MODIFICATION AGREEMENT

THIS LOAN MODIFICATION AGREEMENT, made this

day of Oct. 1998

called "MORTGAGOR" and SOUTHTRUST HORTGAGE CORPORATION , hereinafter called "MORTGAGE
RECITALS:
A. "MORTGAGEE is the owner and holder of that certain Mortgage, Deed of Trust or Deed to Secure Debt, ("the Security Instrument"), dated APRIL 28, 1988 made by the MORTGAGOR to MORTGAGEE recorded in Book 1998 page(s) 16633 Public Record of Shelby, County, State ALARAMA securing a debt evidenced by a NOTE dated APRIL 28, 1998 in the original amount of \$ 252,000.00, which Security Instrument encumbers property more particularly described in said Security Instrument.
B. MORTGAGOR, the owner in fee simple of all of the property subject to the Security Instrument, has requested MORTGAGEE to modify Note and Security Instrument, and the parties have mutually agreed to modify the terms thereof in the manner hereinafter appearing.
"NOW, THEREFORE, in consideration of the mutual promise and agreements exchanged, the parties hereto agree as following, notwithstanding anything to the contrary contained in the Note, Security Instrument or any Rider thereto."
1. As of this date the unpaid principal balance of the NOTE is \$ 252,000.00 the interest has been paid to November 1, 1998
2. The terms of the NOTE are modified in accordance with the terms and provisions which provide:
Principal and interest of said Note shall be payable in consecutive monthly installments to be One Thousand Stx Hundred Forty Three and 08/100
Dollars (\$ 1,843.00) due on the first day of each month beginning DECEMBER 1, 1990 If on MAY 1, 2020 (the "Maturity Date") I still owe amounts under this Note, I will pay those amounts in full on that date.
3. Nothing herein invalidates or shall impair or release any covenants, agreements or stipulations in the Note, Security Instrument and/or Rider(s) and the same, except as herein modified, shall continue in full

4. All MORTGAGEE'S rights against all parties, including but not limited to all parties secondarily liable, are hereby reserved.

Rider, which are not inconsistenet herewith. The Borrower also will comply with all other covenants,

the Borrower is obligated to make under Security Instrument.

5. This Agreement shall be binding upon and shall inure to the benefit of the heirs, executors, administrators and assigns, or successors and assigns of the respective parties hereto.
