Subject to existing easements, current taxes, restrictions, set-back lines and rights of way, if any, of record.

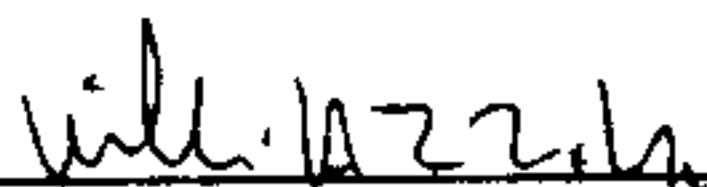
\$32,850.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith.
