CONSTRUCTION MORTGAGE

THIS MORTGAGE IS between Jackle Williams Co., Inc., whose address is P. O. Box 598, Chelsea, AL 35043 (referred to below as "Grantor"); and Regions Bank, whose address is 2964 Pelham Parkway, Pelham, AL 35124 (referred to below as "Lender").

GRANT OF MORTGAGE.
