THIS MORTGAGE IS DATED NOVEMBER 17, 1998, between BETH MARTIN, whose address is 143 LAKE DAVIDSON LN, HELENA, AL 35080-3248 (referred to below as "Grantor"); and Regions Bank, whose address is 417 North 20th Street, Birmingham, AL 35203 (referred to below as "Lender").

GRANT OF MORTGAGE. Grantor will upon request of Lender furnish to Lender advance assurances satisfactory to Lender that Grantor can and will pay the cost of such improvements.

PROPERTY DAMAGE INSURANCE. The following provisions relating to insuring the Property are a part of this Mortgage.

Maintenance of Insurance. Grantor shall produce and maintain policies of fire insurance with standard extended coverage endorsements on a replacement basis for the full insurable value covering all improvements on the Real Property in an amount sufficient to avoid application of any coincurance clause, and with a standard mortgages clause in favor of Lender.
