KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of Ninety Four Thousand Five Hundred and no/100 Dollars (\$ 94,500.00) and other good and valuable consideration to the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged, **LYNN WILLIFORD AND WIFE, DONNA BROWN WILLIFORD**, (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto **MICHAEL JADWIN AND STACEY L. JADWIN**, (herein referred to as "Grantee"), as joint tenants with rights of survivorship, the following described real estate situated in Shelby County, Alabama, to wit:
