KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of One Hundred Thousand Four Hundred and 00/100 (\$100,400.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR, Aberdeen Construction, Inc., a corporation (hereinafter referred to as GRANTOR), the receipt whereof is hereby acknowledged, the GRANTOR does hereby give, grant, bargain, sell and convey unto the GRANTEES, Genie Schuffert Harris, David B. Harris and Ronnie R. Harris, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of SHELBY, State of Alabama, to-wit:

Lot 558, according to the Survey of Weatherly, Aberdeen, Sector 18, as recorded in Map Book 21 page 148 in the Probate Office of Shelby County, Alabama; being situated in Shelby County. Mineral and mining right excepted.

Subject to existing easements, current taxes, restrictions, set-back lines and rights of way, if any, of record.


\$76,687.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith.


