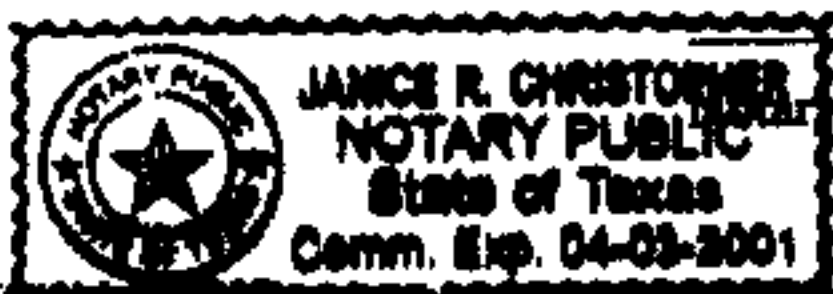

LEGAL DESCRIPTION

Commence at the NW corner of Section 21, Township 21 South, Range 1 West; thence run East along the North line thereof for 1092.40 feet to the Point of Beginning; thence continue last described course for 368.34 feet; thence 90 degrees 00 minutes right run South for 800.93 feet; thence 31 degrees 23 minutes 53 seconds right run Southwesterly 643.67 feet to the North R/W of Shelby County Highway #26 and a curve concaved to the left (having a central angle of 7 degrees 01 minute 50 seconds and a radius of 976.13 feet); thence 109 degrees 53 minutes 20 seconds right to tangent of said curve, run along the arc thereof for 119.78 feet; thence 44 degrees 24 minutes 55 seconds right from tangent of said curve run Northerly for 1262.69 feet to the Point of Beginning.
