NOW THEREFORE, for and in consideration of the premises and of the sum of \$2,000.00 paid by the party of the second part, receipt of which is hereby acknowledged, I Fob James, as Governor of the State of Alabama, and I Ed Richardson as Superintendent of Education of the State of Alabama, in pursuance of the authority conferred upon us by Section 16-20-8 and Section 35-4-385, Code of Alabama 1975, do hereby for the State and in its name grant, bargain, quit-claim and convey and by these presents have granted, bargained, quit-claimed and conveyed unto the party of the second part all of the right, title and interest of the State of Alabama in and to the following described property, to-wit:
