The above described property does not constitute the homestead of the Grantor, Howard T. Hubbard nor his spouse.

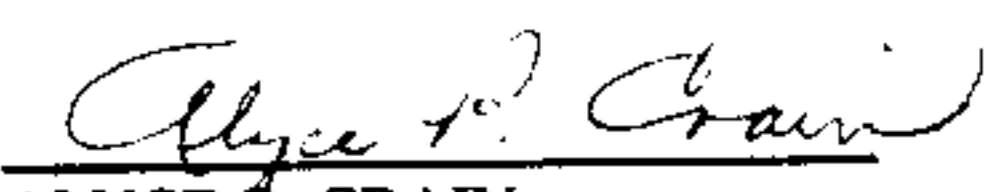
The above recited consideration was paid from a Mortgage loan closed simultaneously herewith.

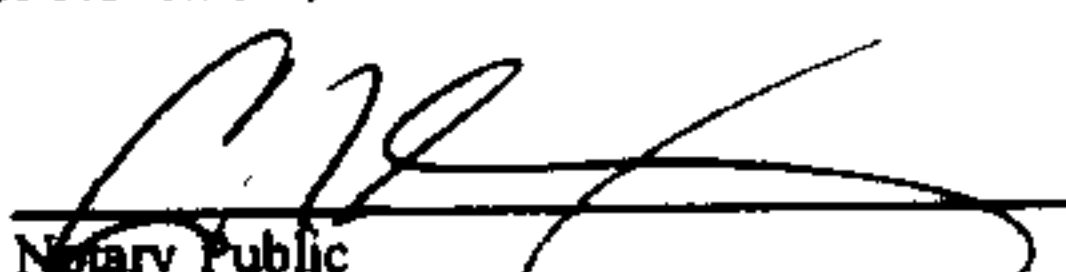
