WARRANTY DEED AND LIMITED POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS: That in consideration of ONE HUNDRED THIRTY TWO THOUSAND NINE HUNDRED AND NO/100***** (\$ 132,900.00****) to the undersigned Grantors in hand paid by the Grantees, whether one or more, herein, the receipt of which is hereby acknowledged, we, **HAROLD J. TAYLOR AND SPOUSE, GENE B. TAYLOR**, (herein referred to as Grantors) do grant, bargain, sell and convey unto ROBIN L.
