THIS MORTGAGE IS between J. Harris Development Corp., whose address is 1109 Townhouse Road, Helena, AL 35080 (referred to below as "Grantor"); and Regions Bank, whose address is 2964 Pelham Parkway, Pelham, AL 35124 (referred to below as "Lender").

GRANT OF MORTGAGE. For valuable consideration, Grantor mortgages, grants, bargains, sells and conveys to Lender all of Grantor's right. title, and interest in and to the following described real property, together with all existing or subsequently erected or affixed buildings. improvements and fixtures; all assements, rights of way, and appurtenances; all water, water rights, watercourses and ditch rights (including stock in utilities with ditch or irrigation rights); and all other rights, royalties, and profits relating to the real property, including without limitation all minerals, oil, gas, geothermal and similar metters, located in Shelby County, State of Alabama (the "Real Property"):

Grantor presently assigns to Lender all of Grantor's right, title, and interest in and to all leases of the Property and all Rents from the Property In addition, Grantor grants to Landar a Uniform Commercial Code security interest in the Personal Property and Rents.
