In accordance with Section 501 (c)(3) of the Internal Revenue Code, and pursuant to the provisions of Section 10-3A-144, Code of Alabama, 1975, regarding the requirements for dissolution of a non-profit corporation; by a majority vote of the board of directors of River of Life Christian Center, it has been determined that all properties and assets owned, deeded, titled to, and or under the control, supervision, guardianship, or care of River of Life Christian Center (Recognized by Federal Tax ID Number [REDACTED]) shall immediately be transferred to River of Life International, Inc., (Recognized by Federal Tax ID Number [REDACTED])

This transfer of properties and assets owned, deeded, titled to, and or under the control, supervision, guardianship, or care of River of Life Christian Center (Tax ID Number [REDACTED]), to River of Life International, Inc., (Tax ID Number [REDACTED]) is inclusive of all lands, properties and buildings at, connected to, or associated with the current address of 19445 Highway 145, Shelby, AL 35143; including all specified or unspecified assets currently residing on any portion(s) of land or property(s) at or associated with this address, including all assets specified or unspecified, attached to or located inside the church building located at 19445 Highway 145, Shelby, AL 35143.
