ARTICLES OF ORGANIZATION

OF

We, the undersigned, desiring to form a Limited Liability Company pursuant to the laws of the State of Alabama, certify as follows:

- 1. The name of the Limited Liability Company is Steve Dichiara Properties, L.L.C.
- 2. The existence of the Limited Liability Company shall commence on the date of the filing of these Articles of Organization in the Office of the Judge of Probate of Shelby County, Alabama, and its duration shall be perpetual; provided, however, that the Limited Liability Company be dissolved (a) upon the written consent of all of the Members, (b) as provided in the Operating Agreement, or (c) as may be required by the Alabama Limited Liability Company Act.

In the event any Person who owns a Class A Unit ceases to be a Manager, such Person's Class A Units shall be converted into an equal number of Class B Units. In the event any Person who owns a Class A Unit Transfers a Class A Unit, such transferred Class A Unit shall be converted into a Class B Unit. In the event a Member who owns no Class A Units becomes a Manager in the manner provided in the Operating Agreement, then the lesser of all Class B Units and one Class B Unit of such Member shall be converted into Class A Units upon such Member becoming a Manager.
