KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, HELENA BAPTIST CHURCH, of the Country and State aforesaid, in and for the consideration of the Country and State aforesaid, in and for the consideration of a cknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby Country, do hereby give, grant, hargain, sell and convey to Shelby Country, its successors or assigns, a Temporary Construction Easement hereinafter described, over and across our said lands in Shelby Country. Alabama, for a public road, said temporary easement herein conveyed being more particularly described as follows, and as shown on the sketch attached hereto and made a part hereof by reference, to-wit:

Containing 0.03 acres, more or less.

TO HAVE AND TO HOLD to the said Grantee, its successors, and assigns for a period or three(3) years, or until the completion of said project, whichever is later. Upon completion of said project, all rights, title and interest to said temporary easement shall cease and the Grantee hereby relinquishes same.

TO HAVE AND TO HOLD by Shelby County, or its Assigns, and for and in consideration of the benefits to our property by reason of the construction or improvement of said road, we hereby release the County aforesaid, and all of its employees and officers, and the State of Alabama and all its employees and officers from all consequential damages, present or prospective, to our property, arising out of the construction, improvement, maintenance or repair of said road, and that said road is a benefit to our property is hereby admitted and acknowledged. All agreements, covering the moving, relocation and/or changing of the building and/or structures located wholly or partially on the above described right-of-way shall be in writing and approved by the State Department of Transportation before same shall be valid and binding on the said State Department of Transportation. The grantor hereby grants permission with right of ingress and egress to grantor's adjoining property at any time during construction period of project for purpose of moving grantor's buildings and/or structures from the above described right-of-way.
