The undersigned, being the only member of AJK, LLC, a limited liability company formed pursuant to Section 10-12-1 et. seq. of the Alabama Code, adopts the following Articles of Organization for such company:

FIRST: The name of the company is AJK, LLC.

SECOND: The term of the company shall commence on the date of the filing of these Articles of Organization in the Office of the Judge of Probate of Shelby County, Alabama, and shall continue for a period of fifty (50) years thereafter; provided, however, that the company shall be dissolved prior to such date (a) upon the written consent of the holders of the portion of the ownership interest of the company specified in the Operating Agreement, as amended from time to time, (b) as provided in the Operating Agreement, as amended from time to time, or (c) as may be required by the Alabama Limited Liability Company Act, as amended from time to time.

THIRD: The purpose or purposes for which the Company is organized are: (i) to take title to, acquire, own, operate, manage, improve, and dispose of real property; and (ii) to transact such other business as may be permitted under the laws of the State of Alabama.

FOURTH: The name and address of the initial member of the Company are as follows:


SIXTH: The Company shall be managed by its members.
