## ARTICLES OF ORGANIZATION

OF

### DISPATCH TECHNOLOGIES, LLC

Pursuant to the provisions of the Alabama Limited Liability Company Act, §§10-12-1 et seq., Code of Alabama, 1975 (the "Act"), the undersigned hereby adopts the following Limited Liability Company Articles of Organization.

#### ARTICLE I.

##### Name

The name of the limited liability company is Dispatch Technologies, L.L.C. (the "Company").

#### ARTICLE II.

##### Duration

The Company shall dissolve and terminate thirty (30) years following the date these Articles of Organization are filed with the probate judge of the county in which the initial registered office is located.

#### ARTICLE III.

##### Purposes

The purposes, objects and powers of the Company are to engage in any lawful business, act or activity for which a limited liability company may be organized under the Act, it being the purpose and intent of this Article to vest the Company with the broadest purposes, objects and powers lawfully permitted a limited liability company under the Act, including, without limitation, the buying, selling, hiring, leasing, operating, dealing in or otherwise using, at any

place or places, real and personal property of any and every kind and description and to engage in any and all activities necessary or incidental to the foregoing.
