If the amount of the Funds held by Lender, together with the future monthly installments of Funde payable prior to the due dates of taxest assessments, insurance premiums and ground rents, shall exceed the amount required to pay said taxes, assessments, insurance premiums and ground tents as they fall due, such excess shall be, at Borrower's option, either promptly repaid to Borrower or credited to Borrower on monthly installments of Funds. - 12. Notice. 
17. Acceleration; Remedies. - 21. Walver of Homestead. Borrower hereby waives all right of homestead exemption in the Property and relinquishes all right of dower and curtesy in the Property.
